2. Objectives of MoU



This agreement has been established between the parties to create an environment for good will & service support system and to conduct and promote the academic activities of training on various topics in India and Abroad.

- 3.2 To provide timely and satisfactory services to the referred patients.



4. Continuity and cease of this MoU
