

This agreement has been established between the parties to create an environment for business relationship and to conduct and promote the business of training on various topics in India and Abroad.



## 3. Primary responsibility of Both the parties shall be as follows :

## 4. Continuity and cease of this MOU



4.1 This MOU should have the status of perpetuity for subsequent years until force to cease by both the parties in writing
