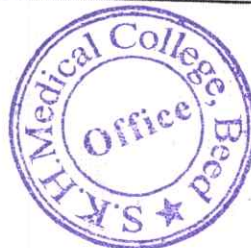




- 1.1 This MOU is having a perpetuity status until forced by both parties to cease.
